The U.S. Constitution can be formally amended in two different ways. An amendment can be introduced by Congress or it can be introduced at a Constitutional Convention. A Constitutional Convention requires that two-thirds of state legislatures request for the convention to happen, and then at this convention, a new amendment can be introduced. If introduced by Congress, the amendment has to be proposed by a two-thirds vote by both Houses of Congress. After the amendment is introduced, it has to be ratified. In order for an amendment to be ratified, it is required that it gains approval from three-fourths of state legislatures or by three-fourths of the conventions called in each state for the purpose of ratification. The process for amending the constitution can be found within Article V of the Constitution.
